The Commission in its meeting held on 23.12.2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to Sumathi Reddy Institute of Technology for Women, Ananthasagar, Hasanparthy, Warangal, Telangana 506371, affiliated to Jawaharlal Nehru Technological University, Hyderabad for a period of 10 years from the academic year 2025-2026 to 2034-2035 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.



ORDER:

In the reference (1) read above, the UGC has Conferred Autonomous Status to Sumathi Reddy Institute of Technology for Women (6Y), Ananthasagar (V), Hasannparthy (M) Warangal (Dist), Telangana affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, for a period of Ten (10) Years from the Academic Year 2025-2026 to 2034-2035 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in autonomous Colleges) Regulations, 2023 for Autonomous Colleges and subsequent regulations issued from time to time by the University.

Also, the UGC has stated that the autonomy granted colleges shall abide by all the provisions of the UGC Regulations for Autonomous Colleges. The college shall apply, in the prescribed format to the UGC, for extension of autonomous status at least three months before the completion of autonomy period.

Under the circumstances as stated above, the Hon'ble Vice-Chancellor is pleased to approve the Conferment of Autonomous Status to Sumathi Reddy Institute of Technology for Women (6Y), Ananthasagar (V), Hasannparthy (M) Warangal (Dist), Telangana affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, for a period of Ten (10) Years from the Academic Year 2025-2026 to 2034-2035 as per clause 7.5 of the UGC Regulations, 2023, subject to ratification by the Standing Committee of the Academic Senate and Executive Council.
