The scholarship is directly handover to the student by the awarding authority or in cases where the amount is credited to the institution; it is immediately implemented.

Note: The scholarship will remain in effect until the student completes the course.

I. Mission

II. Coverage

Candidates are eligible for the following concessions:

- 3. Meal card
- 4. Funding for field trips/any similar excursion undertaken in course work requirement.

III. Eligibility

- 1. Candidate must be a citizen of India.
- 2. Maintain minimum attendance as specified by college rules and regulations.
- 3. Candidate should not be a beneficiary of any other non-govt. award of a scholarship by any party.
- 4. Award of scholarships will be made based on one or more of the following prerequisites:
 - i. SRITW Common Entrance Test (SRITWCET) marks
 - ii. Merit in national/international level examinations
 - iii. Excels in sports.

IV. Application Process:

Candidates have to fill out the online Google application form and upload scanned self-attested copies of the required documents as mentioned in the circular within the prescribed time limit. Candidates have to submit these documents in original for verification by the office whenever requested. Any application incomplete or incorrectly identified will not be considered.

V. Selection

A selection committee is constituted by the management with the Principal as Chairperson, Vice Principal, and Head of Department as committee members. The Committee shall annually develop and revise objective criteria by which it evaluates applications. Such criteria shall be uploaded in circular form on the website. The Selection Committee is responsible for the development of criteria, evaluation of applications, and final award of scholarships. The decision of the Committee shall be final and binding. Only one scholarship is awarded per student per academic year.

VI. Conditions for Termination of Scholarship Award

The award may be cancelled at any time if the candidate is found to have included incorrect details/particulars in their application or to have violated the policies, rules, and regulations of the college, malpractice or misbehaviour.

VIII. Policy Eligibility Constraints

The scholarship policy of the institute encourages a good number of students every year and inculcates the spirit of constant performance. SRITWCET exam is conducted for all first years; those with the best marks get scholarship. This scholarship may vary depending on student circumstances.
