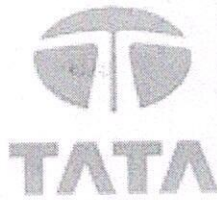

Monthly Performance Pay

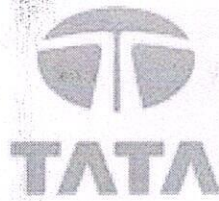
